240	Town Team The Town Team will be an independent committee with a representative from the Town Council and it will be the community who will decide whether there is a need for a Town Team or not. Report to be removed from the Agenda until such a time as a Group is formed.	
241	Traffic on Criffel Street Cllr. S. Graham has received a lot of complaints from businesses on Criffel Street about the speed and traffic on Criffel Street but in particular the early morning empty wagons. It was suggested that a 20mph speed restriction would solve the problem which a lot of towns are opting for. Cumbria Highways had not been in favour of it in the past but the TRO would be coming up again. The cost of signage may be restrictive. RESOLVED that a letter be sent to Cumbria Highways to find out the criteria for having a 20mph speed limit and the necessary signage.	WEJ
242	Premises Licence It was suggested that the council consider holding a premises licence for regulated entertainment on the Green which would then make it unnecessary for each event to apply for a Temporary Event Notice. Cockermouth and Keswick hold a Premises Licence for the town. RESOLVED that the Clerk investigate the benefits of holding a Premises licence and report back to the next meeting.	WEJ
243	Land at West Silloth The football club are willing to donate a set of goal posts to be used on the land as West Silloth which was previously used as a children's play area. Cllr. Pattinson is to arrange a public meeting over at West Silloth to discuss possible future uses for the area.	DP
244	Allerdale Borough Council - Funding An additional £10k is to be provided to the Town Council by Allerdale for projects in the Town. Joe Broomfield would like to come to the next Council meeting to discuss possible projects. There is also £10k of funding to assist with the setting up of Coastal	

	town teams. Joe had suggested putting a big screen on the Green to watch the Tour of Britain live which could be funded from the money from Allerdale. Letters to be sent to Dominic Donini at CCC and the Chief Executive at Allerdale to say that the Town Council is willing to work with anyone wishing to do something for the Tour of Britain and hope they can use the facilities in the town. The drive needs to come from the businesses if they want something to take place and then the Town Council and Allerdale etc will get involved. A meeting has been arranged by Joe on 9 June at 3pm to discuss the Tour of Britain. Brian Irving is currently working on a proposal for the Coastal community team funding which is available from the Government. Bids have to be in by 30 June. Joe to be invited to the July meeting to discuss projects for the funding from Allerdale.	
245	Community Asset Transfer An article was in the Buzz about the Community Asset transfer in which Cllr. Markley was not mentioned despite all the work he had put in. No-one The CAT has gone through no problem at all and the paperwork is to follow. Various pieces of land are to be transferred across to the Town Council for the benefit of the community. Thanks were given to Cllr. Markley and the Clerk for all the work involved in securing the Community Asset Transfer.

247	Roadside Grass Cutting Cllr. The work will provide additional revenue, will cover the initial cost of purchasing the machinery and secures employment for the Council's staff.
