## About Silloth-on-Solway Town Council

Silloth-on-Solway Town Council serves the Town of Silloth with a population of approximately 3,000 residents. We deliver many services in the town, including the provision of open spaces, playing fields and recreation areas. Silloth-on-Solway Town Council is one of around 9,500 Town and Parish Councils within England. Town and Parish Councils are the first tier of local government and work closely with the other tiers of local government, to try and achieve the best for their local communities. ## Town Clerk's Report - Wendy Jameson

During this year, there have been quite a few changes to the composition of the Council.

Sadly, Cllr. Bill Allison passed away in June of last year, after many years of being a very active and valuable member of the Town Council. I think Bill would have been proud to see the continuing improvements made to the Green, a project which he was very much a steering force behind. Bill was a pleasure to work with. He had a special understanding of the Council and how it operated, having previously served as Town Clerk and then years later becoming a Councillor and also Mayor of Silloth. One thing always shone through and that was his love of our town and its people.

In May 2013, Cllr. Margaret Snaith retired from the Council after many years of loyal service and Angus Emmerson was co-opted to fill the vacancy. In September 2013, Mark Orchard was co-opted on to the Council to fill the seat left by Bill. In November, Cllr. Elaine Wannop retired from the Council, after many years of loyal service and her seat was filled by Cllr. James Baxter in January, by co-option. In May 2014, Alaric Weightman retired from the Council, after 11 years of loyal service and at the time of writing, the Council is waiting to fill this vacancy.

At the beginning of the December meeting, there was a minutes silence in memory of Gus Proud, a former long serving member of the Council, who sadly passed away.

It is always a shame when members leave the Council and we value the contributions made by all Councillors. The task of being a Town Councillor can be very demanding, requiring regular attendance at meetings, careful preparation and consideration of issues, understanding of local policies and legal procedures and close contact with the whole community. Our Councillors are a diverse group who bring a wide range of skills and ideas to the Council table but they all share two things: they receive no payment for the work they do and they all want to make Silloth a better place for residents and visitors alike.

This has been a very busy year but with the wide range of projects the Council are involved with and the issues they have to deal with, it continues to make my role as Town Clerk varied and interesting and after 17 years of working for the Town Council, I continue to enjoy my job and look forward to the challenges ahead.

Finally, I would like to thank our Park Manager, Ken Wannop and his team, who work hard throughout the year to keep the Green, our play areas and sports fields in tip top condition. They take a pride in what they do which is reflected in the high standards they achieve. Among a record-breaking 1,447 parks and green spaces, Silloth Green received a prestigious Green Flag Award for 2013/14. The Green Flag Award recognises Silloth Green as a well-managed, high-quality green space which could not have been achieved without the dedicated work of our grounds maintenance team and a band of volunteers from Friends of the Green, Silloth Tourism Action Group, the schools and members of the local community. Hopefully we will be able to repeat the achievement and get a Green Flag Award for 2014/15.

Allerdale is a non-metropolitan district of Cumbria, England, with Borough status. Its Council is based in Workington and the Borough has a population of 93,492 according to the 2001 census.

The Borough of Allerdale was formed under the Local Government Act 1972, on 1 April 1974 by the merger of the municipal Borough of Workington, the urban districts of Maryport, Cockermouth and Keswick; and the rural districts of Cockermouth and Wigton, all of which were within the administrative county of Cumberland. In 1995 Allerdale was granted Borough status.

Allerdale Borough Council in Cumbria, England is elected every four years. Since the last boundary changes in 1999, 56 councillors have been elected from 31 wards.

## Solway Coast Area of Outstanding Natural Beauty



The Solway Coast Area of Outstanding Natural Beauty (AONB) was designated in December 1964 in recognition of the quality of its landscape and its significant historic and scientific interest. It stretches from Rockcliffe in the North to Maryport in the South, covering about 115 square kilometres of the Solway Plain. The primary purpose of this designation is to conserve and enhance the natural beauty of the area.

It contains many locally, nationally and internationally important features some centring on landscape and others on important wildlife and heritage. Many features are protected by designations and collectively they indicate the high value of the area and underpin the need to protect and enhance it for future generations.

The Solway Coast in its present form, has been part of the landscape for 10,000 years since the retreat of the last great ice sheet. Since then, man has settled in the area and has created a mosaic of habitats some of which are relatively unspoilt and others have been modified. The Romans, Vikings, Reivers and eventually ourselves have shaped the Solway Coast into what it is today. There is a wide range of habitats, all of which are fragile, and need our help to conserve and enhance. They include the sand dune coast, the salt marsh coast, the unique lowland raised mires and the agricultural land.

The character of the Solway Coast is linked to its coastal setting and remains relatively unchanged and undisturbed which gives it a strong sense of remoteness and tranquillity.

Celebrating its 50th Anniversary of designation in 2014, look out for events and activities throughout the year and join in with conserving this unique and special area. The Foundation have met three times in the past year, all meetings being held at Wheyrigg Hall. Over the year donations of £1,425 have been made to each of the four schools within the remit of the Foundation i.e. Silloth Primary, Holm Cultram, Holme St Cuthbert and Solway Community Technology College.

Further more, a donation of £100 each has been made to the three Sunday schools i.e. Christ Church Silloth, Holme St Cuthbert and Holm Cultram.

# Silloth Primary School & Solway Community Technology College – Cllr. A.J. Markley

I report on progress to the Town Council in relation to the Schools, as I am a Governor at both Schools.

Both Schools are progressing well. Every time I visit the school I find the pupils extremely polite and friendly.

The Head mistresses and staff are dedicated to support and educate the students in these local schools to a very high standard which is portrayed by the achievements the students have obtained over the years at County and National level.

## Solway Community Sports Hall - Cllr. S. Graham

I have nothing to report, as I have yet to date to be asked to any meetings and must ask the question is it viable for myself to have this group to represent, as I don't feel that they require any Council representation?

## Sea Dyke Charity - Cllr. A.J. Markley

I represent the Town Council on the Sea Dyke Charity which meets at regular intervals throughout the year.

The charity committee is made up of twelve representatives including the local parish councils and local land owners from around the area.

The Charity owns a farm, land and property around the Abbeytown area which are rented out. The committee has a duty after operational and maintenance expenses incorporating various property improvements, these been carried out surplice funds are distributed to local Churches, Village Halls, schools and residential homes within the allotted area to assist with their overheads and operational expenses.

## Silloth Tourist Action Group - Cllr. C. Graham



The onset of 2013 brought changes to officers on the committee, with John Cook taking the Chair role and Vicky Hope taking the Secretary role. Six months later Vicky resigned as Secretary and Chris Graham was asked to take up the role again. There was a resignation from Peter McRobert, a valued and long serving committee

member. We were, however, very pleased to welcome new members, Angus Emmerson, Paul Gilmour, Geoff Betsworth and John and Maggie Dunn. Unfortunately due to personal circumstances John and Maggie have since had to resign.

Although not a committee member of STAG Anna Malina, Community Engagement Officer, has regularly attended our monthly meetings and given valuable support through advice etc on the various projects with which STAG is involved. Her expertise on websites and leadership on funding applications has been extremely helpful.

Western Lakes Tourism ceased trading at the end of February due to the withdrawal of funding from BEC who advised that they wanted to concentrate on projects promoting nuclear excellence. It was hoped that BEC would, at the very least, provide some funding so that the highly successful tourism website could be continued. We are very disappointed that this has failed to materialise. The impact of this on the local tourist economy should not be underestimated. The local tourist economy has gone from being supported by a West Coast centric organisation based in Maryport to an organisation (i.e. Cumbria Tourism) that is based in Kendal and whose main focus is the promotion of tourism in the Lake District. In addition a further negative impact that will be felt is the demise of the Hadrian's Wall Heritage Trust which has been responsible for the promotion of tourism and conservation projects to the north of Silloth, including the AONB and the Solway Wetlands Trust.

The lack of funding in the public sector is having a serious impact on the promotion of the local Solway tourist economy. Silloth falls between the two economic centres of Workington/Whitehaven and Carlisle and as a result it is difficult to attract funding from organisations focused on the regeneration of these two areas. We approached FLAG for funding to carry out a project on the fishing industry of Silloth and surrounding area. Unfortunately the fishing fraternity were finding it difficult to give the time needed to get the project off the ground. We went ahead and made an application to FLAG but could only get 50% of the overall grant required. This was very disappointing as it meant we had £10k to find in match funding which we did not have. Following further discussions there may be

the possibility of receiving a grant of up to 80% with match funding coming from Allerdale Borough Council. Grants have been gratefully received from Neighbourhood Forum and SOSCS which has helped support the smaller projects.

Recently, thanks to the support of Anna, we have received HLF funding to carry out a project on Silloth Airfield. There is much history in this area and in particular the impact the airfield had on the war efforts. It is intended to involve the younger members of the community right through to the senior citizens of the town. Interviews with veterans of World War II will be carried out by pupils and will form part of their school curriculum this year. Professional training will be offered to volunteers so that they can produce a DVD which will be available for sale in local retail outlets. Photographs and memorabilia can initially be exhibited within the Soldiers of Silloth museum but we need to find a more permanent home for the exhibition.

A pilot scheme of holding music on the Green each Sunday (weather permitting) was carried out last year. A mobile staging area was made and numerous artists turned up to entertain residents and visitors alike. Due to its success it is hoped that permission from STC will be given for this to become a regular feature on the Green during the summer months.

A Beach Half Marathon was held last year for the first time starting on the beach and ending on the Green. Following a slow start to the competition, we were rewarded with 50+ runners taking up the challenge. The run will be held again this year and talks are continuing with New Balance on the support they might be able to give. Although their funding has been allocated for 2014, they have been very receptive in supporting us through the provision of clothing this year. The directors of New Balance have advised that they are keen to work in partnership with STAG in 2015 and it is to be hoped that we will be successful in obtaining funding towards the run.

The firework and bonfire event went reasonably well but the weather was poor which reflected on the numbers attending.

New to this year STAG has organised a theatre performance of Treasure Island to be held on the Green by the Rain or Shine Theatre Group. Due to the availability of local funding we have managed to make this a free performance and 300 tickets will be given away through schools etc.

There have been some problems with updating the STAG website which is being managed by a local contractor. The website will not be officially launched until it is fully operational. In the meantime we have linked our website to that of Friends of the Green.

The STAG membership decided that the organisation should become a limited company by guarantee. This will protect committee members from personal liability and makes STAG a legal entity. As such it will improve STAG's status when submitting funding applications. Further consideration is being given on how the limited company will be set up.

Friends of the Green has now become a sub group of STAG rather than being a separate entity. Anna and Owen remain the lead people for this group and are heavily committed in the completion of the community garden. The local school pupils will help out with the planting but the school is reluctant to take on an area of garden to regularly maintain. The woodcarvers have been busy carving a story telling chair weighing 400cwt for the garden! This will be put in place very soon and Tim Barker has agreed to be the first story teller. The very successful Green Day held last May will be repeated again.

STAG is very keen to improve its relationship with STC and has had one meeting so far with STC to discuss how we can achieve this. STAG representatives and STC councillors will meet periodically to review the situation. It was agreed that in recognition of the work that volunteers do for Silloth, an individual or a group of individuals could be nominated to STC for a letter of recognition to be sent from the Council.

#### Friends of the Green - Cllr. S. Graham



Friends of the Green have been very busy in respect of training. To date various members of Friends of the Green have completed training in First aid, Risk assessment and have been proactive in the consultation and working groups for the community garden on the Green. May I take this opportunity to thank those involved and Anna Malina for all her involvement in bringing not only Friends of the Green together but also for putting together the training that has thus been provided.

## North West Allerdale Neighbourhood Forum - Cllr. G. Wilkinson

The forum roughly covers an area bounded by Allonby, Aspatria, Silloth, Anthorn and Bowness on Solway but does not include Kirkbride. The Forum have met three times over the past twelve months.

Below are the main points covered in relation to Silloth:

5 September 2013 - Meeting in Bowness on Solway. Information and discussion in regard to the Solway Coast AONB and Wetlands project. A grant of £500 was made to STAG for the Fire show on the Airfield.

10 December 2013 - Meeting at Aspatria Rugby Club. Information and discussion with Allerdale Town Centre manager, West Cumbria Carers and Age UK West Cumbria. Grants were made to Soldiers in Silloth £500 for a display cabinet, Silloth Rugby Club £1,500 for a Youth team shelter and to Friends of Silloth Green £1,250 towards funding for Children's entertainment on Green Day.

4 March 2014 - Meeting at Silloth Primary School. An update on planned events on the Green by both STAG and Friends of the Green. Grants were made to Christ Church Hall £390 for electrical works, Silloth Vintage Rally £590 for entertainment at the Rally, Silloth Tots and Toddlers £350 for a storage shed and STAG £1,250 towards a theatre production on the Green in August.

At each meeting there are also reports given by representatives of Parish and Town Councils on the matters being dealt with.

#### A message from your Neighbourhood Policing Team

Cumbria Police are urging householders to keep doors and windows locked to prevent 'sneak-in' thefts. With the warmer weather upon us, please ensure front doors and windows are locked if you are out in your back garden enjoying the sun. Also, at night, ensure your house is secure after leaving windows open during the day.

Householders are urged to ensure that sheds and outbuildings are locked securely after using items from them and review their security, considering locks, lighting, alarms and other security devices if relevant.

Thefts of pedal cycles have increased recently and owners are requested to lock their cycles, even if left for a short time. If cycles are attached to vehicles, please also lock them to the vehicle if leaving unattended, even for a short space of time.

Finally, sheep thefts have been on the increase in the rural areas and anyone noticing anything suspicious is asked to contact the Police on 101. Officers have recently undertaken further training to detect these types of crimes.

Farmers and other authorised persons can easily be checked by the Police to ensure their credibility. ## Services provided by the Town Council

**Silloth Community Hall** – The administrative centre of the Town Council, the Community Hall provides offices for the Town Clerk and the Community Engagement Officer and also houses the Council meeting room. There are rooms and kitchen facilities available for use by individuals, local groups and organisations for meetings etc. Last year work was carried out to make the exterior of the building watertight, with work currently underway to refurbish the kitchen, toilets and hallway. **Public Open Spaces** – The Town Council manage large areas of public open spaces. Silloth Green incorporates Harbour Green, a large area known simply as 'the Green,' and Skinburness Green which is one of the largest and longest village Greens in England. The Town Council also own and maintain land at New Street and an area of land at West Silloth which was formerly used as a children's play area.

**Sports and Recreation** - The Town Council are responsible for the maintenance of the Eden Street sports fields, the football changing rooms, the former Squash court which is occupied by the Solway Fitness Centre and the tennis courts on Skinburness Road.

**Playgrounds** - Within our Open Spaces, the Town Council is responsible for the up-keep of the playground at Eden Street, the Woodland play area on the Green, the Water Splash park and the new BMX track. They are looked after by the Council's grounds maintenance team and are regularly inspected to ensure they are clean and safe. An independent annual safety inspection is also carried out.

**Allotments** - Silloth Town Council's allotments are situated at the top of Eden Street, adjacent to Skiddaw Street and are available to rent by residents of Silloth. Allotments are extremely popular and there is often a lengthy waiting list.

**Street Furniture** - The Town Council owns and maintains benches, seats, bins and notice boards on the Green and other areas.

**Civic Services** - The Mayor of Silloth is happy to support any Silloth-based resident, organisation or group as far as diary commitments allow. If you would like the Mayor to attend an event, please contact the Town Clerk or the Mayor direct.

**Planning Applications** - The Town Council monitors all planning applications applicable to areas within the Township, making representations to the Planning Authorities as necessary.

**Representing local views** - The Town Council has actively promoted the views and interests of Silloth to national, regional and county level government on a host of consultative matters.

**Council Offices and Support Services** - The Town Clerk provides a full range of management, financial and administrative support to the Council, the Mayor and its staff. The Town Clerk is usually the first point of contact for members of the public, who have questions to bring up with the Council. The Community Engagement Officer was employed as part of the HLF funding bid for Silloth Green. Anna works with local organisations such as Silloth Tourism Action Group, Friends of the Green and the schools etc, to promote Silloth Green and is also involved with other projects.

#### **Finance**

The Town Council is required to make arrangements for the proper administration of its financial affairs and to ensure that one officer is responsible for the administration of those affairs. This requirement is detailed in the Local Government Act 1972 (s.151). The Town Clerk is the "Responsible Financial Officer" for the Town Council.

The Town Council is responsible for ensuring that its financial management is both adequate and effective. This process of management includes a sound system of internal control that includes arrangements for the management of risk. The Town Council conducts an annual review of the effectiveness of internal control.

The Town Council maintains accounts and supporting records in accordance with the appropriate legislation and national guidelines. A budget is set for the financial year and regular reports are submitted to Town Council meetings in order that councillors can scrutinise the Town Council's financial position.

At the end of each financial year (31 March), a Statement of Accounts is produced for consideration by members of the Council. Each year the Accounts are audited by the internal Auditor, Mr P. Wilson and the Annual Return is then submitted to the external auditors BDO LLP at Southampton. The Accounts and Annual Return is available for public scrutiny.

#### How is the Town Council Financed?

The net cost of the Town Council's activities in 2014 - 2015 is financed by levying a precept, which is added to the Council tax levy set by Allerdale Borough Council. In 2014 - 2015 the Town Council are raising a sum of £119,893, resulting in a charge on the council tax on a Band A property of £100.91 for the whole year. The previous year's precept in 2013 - 2014 was £109,339.

Silloth Town Council considered its budget in detail, in a bid not to increase the Precept. Despite its best efforts, the amount charged to each household increased this year due to other factors. The concurrent grant system has been phased out and from 1 April 2013, national council tax benefit was replaced by council tax support which took the form of reductions within the council tax system and affected the council tax base. For 2014-2015, the Town Council received £4,728 in Council Tax Reduction Scheme Grant from Central Government. The Town Council no longer receive any financial support from Allerdale Borough Council towards the maintenance of the Green which has resulted in a reduction of £20,000 in income for 2014 -2015.

- Purpose of the Annual Town Meeting The main purpose is to enable the registered electors to discuss
  matters which affect the town and to pass resolutions thereon. This meeting is also an opportunity for the

- Who can attend the meeting? Anyone may attend but only registered electors in the town of Silloth may speak and vote.
- Will I be able to ask questions and make resolutions? Yes, any registered elector may ask questions of the
  Council. These will usually be answered by the Chairman or by the Town Clerk or a designated Councillor.
  An elector may also make suggestions and comment on town issues and propose resolutions. Resolutions
  relating to allotments are legally binding but all others are persuasive only, but will be considered by the
  Town Council at future meetings.
- Who will chair the meeting? The Chairman of the Town Council must chair the meeting, if present. In his absence the vice chairman must preside if present. If neither is able to attend, then the meeting will elect a chairman from those electors present.
- Will Town Councillors be there? Although there is no compulsion, Councillors normally attend. They will speak if required, but the purpose of the meeting is to enable the ordinary electors to have their say. Councillors will listen with interest and as electors themselves, also have the opportunity to raise questions and make comments if they wish.
- **How long will the meeting last?** As long as need be within reason. It really depends on those present and the number of questions and the discussion that is raised. The meeting will probably last one hour.
- Will the Press be there? The local press are allowed to attend the meeting, as they are for all meetings of the Council.
