#### 639 Minutes

After some minor amendments the minutes of the meetings held on 6 & 20 December were approved by the Town Council and signed by the Chairman as a true record.

#### 640 Police Report

#### 641 Community Hall - Refurbishment

Anne Sowerby & Clive Firth attended the meeting to give an update on what is going on with the refurbishment plans for the Hall. Some funding has been applied for. Application for £12k submitted to Cumbria Waste Management will be considered tomorrow. Received £5000 from CCC Allerdale area committee and there may be more funding available in the pot. Applied for £15 from the Solway Coast AONB but they needed a business plan which they were not ready to do at that point Silloth Town Council are funding the painting of the outside of the building which will be used a match funding. There will be a Phase 1 and a phase 2. Business plan has now been done. Work has been time consuming. Anne asked if anyone would be willing to join the board. Some of the members are retired. She asked if there were any other funding pots that could be accessed. Cumbria Community Foundation - priorities are Workington and Whitehaven etc. The solar panels on the roof would generate income. Area committee money would have to be spent by April. Could also apply to Wren and Awards for All. AONB is operating on a small budget. Sustainable Development fund is a possibility. Need to set up a meeting outside the normal Town Council meeting to move it forward. Anyone interested in getting involved is welcome.

# Outline Planning Application (LPA Ref: 2/2010/0037) Redevelopment of former Fisons Factory, Silloth - Alternative Route to the Town Centre

Matthew Stafford from WA Fairhurst & Partners attended the meeting to give the Council the opportunity to ask any questions and reassure them if there were any concerns. A

section 163 agreement is needed with the Town Council being landlord. The developers were asked if they would be willing to upgrade the footpath from West Silloth across the playing fields. From discussions with CCC this is not a statutory footpath. The developers are having to pay £20k to CCC for crossings etc within the town. The new footpath will be to an adoptable standard. Costing approx £120k to build the new link. Silloth Town Council will be responsible for the maintenance of the new footpath when it is put in but it has a 25 year design life, therefore no maintenance for some time. It was suggested that the footpath be fenced off to make sure people keep to the path and do not divert across and through the playing fields. Everything is progressing well and they are currently in the throws of getting a legal agreement with Allerdale. A new plan will be issued with a fence shown - with a specification to be agreed. It was agreed to proceed with the section 106 agreement, as long as there is no costs to the Town Council. Trevor Gear will look over it and come back to the Town Council. If Mr Gear does not agree to look over it for the Town Council, then Council can appoint their own solicitor, the cost of which will be paid by the developers.
