#### 711 Minutes

# 713 Fisons Factory Site - Section 106 Agreement

Trevor Gear and Sarah from Allerdale Borough Council attended the meeting to discuss various matters in relation to the 106 agreement. Questions were raised re: Highways projects in respect of 106 agreement with County Council. Only involvement the Town Council have had re 106 is in regard to the new footpath. The Highways projects have come via a traffic regulation order drawn up through consultation with the public at neighbourhood forum meetings. Highways have approved the development through the Travel Plan. The plan has now transferred to Harvest Developments. The Harkers names have been removed from the 106 agreement. Various questions were raised re: the Footway. The Town Council have not seen any section plans of the footway nor any drainage detail or lighting information. Concerns were raised in respect of footway encroaching on to the football pitch. At best it should be 10ft clear.

Also clarification of the maintenance of the footpath needs to be established. The site has outline approval only with the junction details agreed by the County Council. Any outstanding points need to be ironed out between the Town Council and the developer prior to signing. If possible another meeting needs to be arranged.

Trevor Gear and Sarah left the meeting.

#### 714 Silloth Community Hall - The Space

Update on progress and consider how to move things forward. A.O.N.B. have turned down

the application for funding. A new bid for funding has been made to Cumbria Waste Management to be heard in May. Trying to find new funders - Awards for All etc. The project could be slowed down but the building needs urgent renovation I.e. toilets etc. Three quotes have been received ranging from £35 - £50 - £60K approx. In discussion it was agreed that the Town Council should be maintaining the property as we own it, with possible help from the users. There may be some funding via HLF bid as an office will be required. As a Town Council we should get a builder in as soon as possible to get to the bottom of the damp. There may be problems on the roof.

The woodcarvers are proposing to have an open weekend on 22 - 23 April to show the work to the public with possible other groups to join in.

Clive asked if they could mount a cabinet on the wall in the hall to show off what they make. This was agreed. He also asked if it was ok to place their sign out from when they are in the building. This was agreed.

There is a need for a first aider to be on site. It was suggested that they contact the first responders or St John's Ambulance.

Town Council should give written agreement to match the funding from Cumbria Waste Management.

Following discussions it was felt that the tennis courts are Council owned and we should maintain them. If funds are available in 2010/11 or 2011/12 budget. Another meeting should be held a.s.a.p. when we know what funds are at hand
